### UI Research and Innovation Discourse (UI-RID) held on Wednesday, 19 February 2025

The 11<sup>th</sup> edition of the University of Ibadan Research and Innovation Discourse held on 19<sup>th</sup> February 2025 with an opening remark by the Deputy Vice-Chancellor, Research, Innovation and Strategic Partnerships (Professor Oluyemisi Bamgbose, SAN).

The DVC, RISIP on behalf of the University Management welcomed and thanked all who have been participating in the research discourse. She congratulated the Director of RMO and his team for continually making the research discourse to happen, and thanked our discussant, Professor Ayantayo. She commented on the topic and stated that she would like to know the hidden connections and collaborative opportunities between STEM and Sacred. According to her, research and innovation discourse is very important because it brings out the research we carry out in the university.

Professor Ayantayo in his presentation titled: **“STEM and Sacred: Investigating the Hidden Connections and Collaborative Opportunities”**, said people think there is no connection between STEM and Sacred. Sacred according to him is used metaphorically to mean religious studies. He stated that the major issue is that, there is this believe that there is no connection between religion and science. Many people think religion is essentially practice about faith while science is written based on reason, empirical. This informs believe that STEM is higher in value than religious studies. This is why the national science, technology, and innovation policy and other national documents are showcasing that STEM is higher in value than anything humanities, but this is not the case. It is this gap that there no possible connection between STEM and sacred that this work intends to fill. The gap already created a line of demarcation between science, technology, engineering, and mathematics.

Professor Ayantayo stated that the scope of the study is the University of Ibadan. He gathered the prospectus and handbooks of various faculties and departments in the faculty of science and technology, looked through their courses and discovered some connections with religious studies. He defined religious studies as the study of religion and stated further that religion is a critical investigation of religion phenomenon. He said both religion and science are given to man. While science focuses on the scientific dimensions to man, religion offers something to assist man spiritually. He concluded that religion and science have the same focus, but the approach varies.

In his study, Prof Ayantayo did a content analysis of the document collected and the number of courses in these two areas (STEM and Religious Studies) to see the area of collaborations. The theoretical framework adopted for the analysis is grounded in Allen F. Repkos interdisciplinary integration theory which emphasizes breaking down boundaries and finding common ground, synthesize knowledge to create understanding of complex subject. The relevance of the theory

is to uncover hidden connections and potential collaboration between STEM and religious studies in Nigeria.

Professor Ayantayo highlighted some areas of collaborative opportunities. In the area of statistics, it was discovered that statistical methods can be used to track Christian and Muslim population in Nigeria. Religion demography through mathematics can help analyze census data on Nigerian Christians, Muslims, and African Traditional Religion (ATR) population, zoology explains animal's role in Christian, Muslim, and ATR, ethnozoology examines animals like python, vulture in ATR practices, creation and evolution debate in evolution biology, civil engineering has a template for church or mosque building because of its symbolic nature. He explained the role food technologist played in fasting. When fasting, do one take water, what type of food can one use to break the fast? He discussed the difficulty people had in accepting IVF in Nigeria until recently because of the perceived believe that scientists want to take the place of God and that it's only God who can give a child. Professor Ayantayo also talked about anointing, anointing water, incense, and various herbs that people use which are exposed to bacteria. He averred that if the formula for water is  $H_2O$ , then scientists should be able to find out the formula for anointing water. He proposed courses like biotechnology, bioethics and so on. He raised concerns about chemical safety in religious rituals and that the chemical nature of incense, anointing oil, herbs should be studied as most of them are exposed to bacteria and people are taking it. He advocated for synergy between scientist, chemists, and religious studies.

Professor Ayantayo mentioned that one of the hidden opportunities is the introduction of faith-based health intervention where health programmes can be design through the integration of religious beliefs that will enhance vaccine acceptance, mental health care, and chronic disease management. The relevant courses where these can feature are public health, epidemiology, behavioral science, religion and medicine, theology of healing. Another area that can be explored is in the field of Neurotheology and consciousness studies. This he said can be done in investigating how religious experiences affects brain function and mental well-being which led to new therapeutic techniques in the field of psychology, neuroscience, religious experiences and mysticism, theology, and the mind.

Professor Ayantayo stated some of the interdisciplinary opportunities as science, religion and ethics in Nigeria or environmental stewardship and religious ethics. He said joint research could be carried out on religious influence on public health, artificial intelligence and religious text opportunities, herbal medicine and faith healing etc. The job opportunities provided through these collaborations are ethics consultants for emerging technologies, faith-based science communicator and educator, religious data analyst and social researcher, technologist for digital religion and AI theology.

He emphasized on joint research opportunities in the area of religious influence on public health and disease prevention, AI in religious text analysis, religious organization in environmental conservation, neuroscientific basis of religious experiences, religious dietary laws and food technology, mathematical pattern in sacred architecture, religious perspectives in space exploration, religious ethics and biotechnology etc.

Professor Ayantayo highlighted some of the challenges faced such as, perceived conflict between science and religion, ethical and moral concerns, institutional barriers to interdisciplinary research, insufficient funding for collaborative research, resistance to technological innovation in religious practice. He said the way out is to promote science-religion dialogue, enhance interdisciplinary education, address ethical and theological concern, and increase research funding for institutional support.

In conclusion, Professor Ayantayo recommended that the University of Ibadan boldly established a new degree programme titled 'STEMRES' – an innovative fusion of STEM and Religious Studies, an interdisciplinary course that will attract scientists, technologists, religious leaders, religious scholars that will foster a dynamic exchange of ideas across fields.

In his closing remark, the Director of Research Management Office, Professor A.S. Jegede thanked Professor Ayantayo for the insight into this area. He stated that the curriculum will always be there but what is important is how we translate this into innovation in our own rights and that is what we achieve by redirecting our research agenda as individuals and our commitment to making a difference in this area.

He also thanked and appreciated the Department of Religious Studies and their contributions to the development of interaction between science and humanities. On behalf of the Deputy Vice-Chancellor, Research, Innovation and Strategic Partnerships, he thanked everyone for their active participation at the event.

# PREVENTION OF SPREAD OF COVID-19

The novel coronavirus (SARS-CoV-2) is a new strain of the virus that has not been previously identified in humans. SARS-CoV-2 is the virus that causes coronavirus disease (COVID-19). The Federal Ministry of Health, through the Nigeria Centre for Disease Control (NCDC), has activated a national Emergency Operations Centre at the highest level and is leading the national response. A National Rapid Response Team has been deployed to support affected State Governments with response activities.

As at 1st of May 2020 there were 18 laboratories in NCDC's molecular laboratory network with the capacity to test for COVID-19 in Nigeria, more are still being added. These laboratories were sufficiently equipped with reagents and supplies for testing.

On the 27th of April, President Muhammadu Buhari announced that there would be a phased and gradual easing of the lockdown in these locations. He added that, however, the following additional preventive measures would be enforced:

- Mandatory use of non-medical face mask/covering for all persons while in public spaces. Use of medical latex hand gloves are prohibited
- Mandatory provision of handwashing facilities/sanitizers and extensive temperature checks in all public spaces. Anyone with temperature above 38 degrees Celsius will not be allowed into public spaces and should be told to return home
- Mandatory temperature checks in public spaces
- Prohibition of interstate travel except for essential travels and services
- Prohibition of gatherings of more than twenty (20) persons outside of a workplace
- Prohibition of gatherings of more than twenty (20) persons at a funeral; all infection prevention and control measures and physical distancing of 2 metres must be adhered to
- Controlled access to markets and locations of economic activities
- Physical distancing of 2 metres between people in workplaces and other public spaces

## HOW TO PROTECT YOURSELF

Members of the University Community should undertake simple measures to prevent the spread of the virus, by following these measures:

- Wash your hands frequently with soap under running water for at least 20 seconds or use an alcohol-based sanitiser if water is not available
- Cover your mouth and nose properly with a tissue paper when sneezing and/or coughing. Dispose of the tissue properly immediately after use. You may also cough into your elbow if a tissue is not available
- Maintain at least 2 metres (6 feet) distance between yourself and anyone who is coughing or sneezing repeatedly
- Maintain at least 2 metres (6 feet) distance with other people when in public places
- Wear a non-medical face mask/covering when leaving the house
- Avoid touching your eyes, nose and mouth with unwashed hands.
- Ensure routine cleaning of high-contact areas such as toilets, door handles, telephones, light switches etc.
- Consciously distance yourself at least two (2) meters to the next person. Stay 6 feet away, especially if the person around is coughing or sneezing.
- Do not shake hands or hug any person.
- Unnecessary visitors should not be allowed
- An ill person should be asked to stay away from the office

The communities have experienced dramatic environmental changes and settled in villages or towns, but also still spend time foraging in nearby nature reserves. Comparing activities in both environments allows us to examine differences between former and current modes of subsistence and how environmental change impacts social and moral norms.

The successful candidates will carry out fieldwork in either a Ju'hoansi community in Namibia or a Batek community in Malaysia. Fieldwork includes video ethnography, documenting and analyzing children's everyday interactions with caregivers and peers across environments, as well as interviews and psychological experiments.

We will also consider applicants who propose to do fieldwork in a different community that they may already know and have field experience in, as long as the site has the required criteria to be comparable with the others: firstly, the community must have transitioned from one environment and mode of subsistence to another within the past 50 years; and secondly, they must continue to spend time in the original environment practicing their original mode of subsistence (e.g., they live in villages but still go on frequent hunting treks, or they spend one season in the old environment and another season in the new one). ## Child support\*

## Foundation for the Sociology of Health and Illness (FSHI)

### Background

Preeclampsia is a leading cause worldwide of maternal morbidity and mortality, premature birth, stillbirth, and neonatal death. Preeclampsia is a placental disease caused by two different pathologies during pregnancy. Early-onset disease, caused by reduced uteroplacental blood supply, is a major driver of fetal mortality. Late-onset disease, caused by increased fetoplacental demands, is a major driver of maternal morbidity and mortality. These two pathologies converge on elevated levels of the protein sFlt1 and concomitant decreases in PlGF.

This mechanistic understanding is being translated into new strategies to reduce the burden of preeclampsia. Therapeutic candidates are being developed that target sFlt1 activity, and levels of this protein can be used in screening for preeclampsia risk. Effective screening and low-dose aspirin therapy early in pregnancy has been shown to prevent early-onset preeclampsia and to ameliorate the disease's consequences for the fetus.

Despite the growing understanding of preeclampsia biology, questions remain about heterogeneity of the disease across patients and the degree to which there are distinct subtypes and etiologies. New approaches are also needed to more quickly and comprehensively reduce the burden of preeclampsia, especially those suitable for the health care infrastructure in the countries with the highest burden.

### The Challenge

We seek proposals for innovative solutions for the early detection, prevention, and treatment of preeclampsia, particularly in low- and middle-income countries where maternal mortality rates are high. To support this focus, we are looking for collaborations, including those with research institutions, health care providers, and global health organizations, that enable cross-sector insights and ensure that solutions are adaptable and practical.

The objectives of the challenge are:

1. **Early prediction and detection of preeclampsia.** We seek biomarkers (including other than sFlt1 and PlGF), diagnostic tests, and point-of-care technologies to predict early in pregnancy the risk of preeclampsia and to diagnose it before symptoms become severe.
2. **Understanding the pathophysiology of preeclampsia and its heterogeneity.** We seek to understand the biological mechanisms driving the disease and its subtypes so that new interventions can be effectively tailored to the underlying etiology.
3. **Preventive and therapeutic interventions.** We seek new approaches to known targets or new targets to reduce the incidence and severity of preeclampsia, mitigate disease progression, and prevent the cardiovascular and metabolic complications that often follow it.

### Funding Level

We will consider proposals for awards of up to \$500,000 USD for each project, with a grant term of up to 2 years. Application budgets should be commensurate with the scope of work proposed. Indirect costs will be considered, and should be included in the budget for the up to \$500,000 USD award (subject to the [Gates Foundation's indirect cost policy](#)).

Current measurement frameworks, such as the Disability-Adjusted Life Year (DALY), fail to capture the full complexity of women's health outcomes, as they do not account for the multidimensional factors that shape health burdens and progress. These dominant contribute to poorer health outcomes in women, yet they remain inadequately reflected in existing indicators. Without alternative metrics often overlook gendered conditions and social determinants of health, limiting the ability to generate actionable insights. Harmful

norms and gender-related discrimination often approaches that incorporate gender-sensitive and multidimensional factors, policies and interventions risk being misaligned with the real needs of women globally. This gap leaves critical gender-related conditions and non-health interventions unmeasured, further hindering progress in advancing women's health.

This Grand Challenge aims to bridge this gap by fostering innovative modeling approaches that rethink how women's health is measured, using available data, or easily obtainable, in new ways to provide a more holistic and actionable understanding of health outcomes. Advances in data science, modeling techniques, technological development, and gender-sensitive approaches present a unique opportunity to innovate; especially when global systems are facing unprecedented shifts that could further increase gaps in equity.

This Grand Challenge builds on the [Women's Health Innovation Opportunity Map 2023](#), developed collaboratively by over 250 global stakeholders across 50 countries through the [Innovation Equity Forum](#) (IEF). The [Opportunity Map](#) identified key gaps and priorities in women's health, emphasizing the need for innovation across multiple areas, including data and modeling, health and economic impact, supply and access to services, and skills, knowledge, and networks. The [Opportunity Map](#) serves as a roadmap for transformative solutions that address systemic barriers and advance gender-equitable health outcomes for women.

This Grand Challenge on **Innovative Data and Modeling Approaches to Measure Women's Health** Seeks to advance innovative ways to measure women's health by either developing new measurement models or adapting existing ones to better capture the full scope of women's health burdens and progress. This Grand Challenge prioritizes solutions that leverage data sources that are existing or under development rather than relying on new, large-scale data collection efforts, ensuring sustainability and feasibility. Applicants are encouraged to build upon existing work, whether by enhancing ongoing projects with a stronger gender-sensitive approach, refining existing models, or expanding available datasets in ways that align with the Challenge's objectives. While this Grand Challenge does not fund broad new data collection efforts, proposals that require small-scale dataset expansion - where such an extension would significantly improve gendered analysis that generate policy-relevant measurement approaches that improve how women's health is understood and addressed globally - may be considered.



# CALL FOR GRANTS AND APPLICATIONS

The Challenge: We invite applicants to explore bold, innovative approaches. Specifically, the **Objectives** of the Challenge will be to: Reimagine new ways to understand and measure women's health that extend beyond the limitations of existing composite indicators such as DALY.

Use existing data sets or easily collectible datasets to quantify women's health outcomes across countries. While this Grand Challenge does not fund large-scale data collection, proposals may include small-scale data expansion where it is feasible, policy-relevant, and significantly enhances gendered analysis.

Design innovative methodologies that incorporate gendered, socio-cultural, economic, and structural determinants of health, ensuring a comprehensive gender-sensitive approach (A gender-sensitive approach takes into consideration how one's gender impacts access to services, risk and protective factors and barriers that are uniquely experienced because of one's gender in a society).

Create tools or frameworks that enable cross-cultural or subnational comparative analysis, identifying context-specific gaps and progress.

Reflect the interconnected dimensions of women's health across the life course

Incorporate gaps in the measurement of:

**Skills, knowledge, and networks:** addressing how gender disparities in education, training, and professional networks impact health access, decision-making, and service delivery.

**Supply and access to services:** examining how health systems, financing mechanisms, and gender-based barriers affect the availability, affordability, and accessibility of essential services for women

**Health and economic impacts:** capturing the intersection of health outcomes with economic participation, caregiving burdens, workforce inclusion, and financial independence.

Produce outputs that are:

**Methodologically rigorous:** applying sound data science, statistical modeling, or analytical techniques that enhance the validity and reliability of women's health measurements.

**Interpretable and actionable:** ensuring results can be understood and applied by policy makers and implementers.

**Comparative and scalable:** enabling cross-cultural or subnational analysis to identify patterns, disparities, and opportunities for intervention.

**Gender-sensitive and intersectional:** incorporating the social, economic, and structural determinants that affect women's health outcomes.

**Policy-relevant and decision-oriented:** providing insights that have the potential to directly inform policies, resource allocation, or program design to improve women's health measurement and action.

## Funding Level

We will consider proposals for awards of up to \$150,000 USD for each project, with a grant term of 18-24 months.

Application budgets should be commensurate with the scope of work proposed. Indirect costs will be considered and should be included in the budget for the up to \$150,000 USD award (subject to the [Gates Foundation's indirect cost policy](#)).

## Eligibility Criteria

This initiative is open to nonprofit organizations, for-profit companies, international organizations, government agencies and academic institutions. We particularly encourage applications involving projects led by women, early-career researchers and practitioners seeking to innovate in women's health measurement, or from women-led organizations and applications from institutions based in low- and middle-income countries. We also encourage collaborative submissions across disciplines such as economics, public health, and gender studies.

### We are looking for proposals that:

**Demonstrate innovative thinking** in modeling women's health, providing creative methodologies or tools to address gaps in measurement.

**Leverage existing data sources** and/or explore datasets that are feasible to collect within current capacities.

Incorporate **intersectional approaches**, addressing disparities (social, economic, and structural determinants of health) that disproportionately impact women.

Align with the

**Opportunity Map dimensions**, focusing on multidimensional indicators beyond traditional composite measures. Show potential to **generate actionable insights** for policy and programmatic interventions at a national and/or global scale.

**Enable cross-country or subnational comparisons**, offering solutions that reveal context-specific gaps and opportunities for progress.

Present a clear pathway for **real-world impact**, outlining how the outputs can inform resource allocation, policy, or program design.

Highlight the potential for **scalability and adaptability** of the proposed approach across diverse country contexts.

Promote interdisciplinary collaboration, combining perspectives from multiple sectors such as public health, data science, economics, and gender studies.

### Funding Information

### Eligibility Criteria

- Proposals to the Small Research Grants on Education program must be for research projects that aim to study education.
- Principal Investigators (PIs) and Co-PIs applying for a Small Research Grant on Education must have an earned doctorate in an academic discipline or professional field. While graduate students may be part of the research team, they may not be named the PI or Co-PI on the proposal.
- The PI must be affiliated with a non-profit organization or public/governmental institution that is willing to serve as the administering organization if the grant is awarded. Examples include non-profit or public colleges, universities, school districts, and research facilities, as well as other non-profit organizations with a 501(c)(3) determination from the IRS (or equivalent non-profit status if the organization is outside of the United States). The Spencer Foundation does not award grants directly to individuals.
- Proposals are accepted from the U.S. and internationally, however, all proposals must be submitted in English and budgets must be proposed in U.S. Dollars.

### Ineligibility Criteria

- Proposals for activities other than research are not eligible (e.g., program evaluations, professional development, curriculum development, scholarships, capital projects, software development). Additionally, proposals for research studies focused on areas other than education are not eligible.

### Review Criteria

- The review panel for this program is made up of scholars in the field of education research with expertise across many disciplines and methodological areas. Panelists are asked to rate and comment on the following aspects of your proposal:
  - Significance of the Project: Reviewers will evaluate the centrality of education in the research, the importance of the topic to its field, and the quality of the research question(s) and/or direction of inquiry.
  - Connection to Research and Theory: Reviewers will evaluate the adequacy of the description of how other researchers have treated the same topic and how well the proposal responds to prior work and theory.
  - Research Design: Reviewers will evaluate the overall quality, sophistication, and appropriateness of the research design as well as its alignment with the research question(s) and/or conceptual framing.
  - Budget and Timeline: Reviewers will evaluate the adequacy of the budget and timeline.
  - Project Team: Reviewers will comment on the potential of the investigator(s) to complete the study as described and share the results or other findings.

The **Seed Grant for New African Principal Investigators (SG-NAPI)** was established in response to the needs of researchers in developing countries, particularly those attached to institutions that lack appropriate research facilities. Under this scheme, grants can be awarded for research projects in Agriculture, Biology, Chemistry, Earth Sciences, Engineering, Information Computer Technology, Mathematics, Medical Sciences and Physics to Principal Investigators in the African countries lagging in science and technology identified by TWAS, to enable them to purchase the research facilities they need to enhance their productivity.

The **Seed Grant for New African Principal Investigators (SG-NAPI)** aims to support early-career scientists in Sub-Saharan Africa, with particular emphasis on Least Developed Countries (LDCs).

**Seed Grant for New African Principal Investigators (SG-NAPI)** is fully funded by **The German Ministry of Education and Research (BMBF)**.

### Programme Details

- **SG-NAPI** Grants are awarded to high-level promising research projects in **Agriculture, Biology, Chemistry, Earth Sciences, Engineering, Information Computer Technology, Mathematics, Medical Sciences and Physics** carried out by

- Principal Investigators (PI) in the African countries lagging in science and technology identified by TWAS.
- Research Grants to research units amount to a maximum of USD 67,700.
- The grants, typically awarded for a duration of 24 months, can be utilized for the purchase of scientific equipment and consumables. This includes in exceptional cases partial funding for fieldwork, maintenance of equipment and specialized literature, such as textbooks and proceedings only. The **grant does not cover salaries** of the Principal Investigator or travel expenses unless they are clearly related to one of the conference and/or mobility components mentioned below. Additionally, please note that the **purchase of fuel, fees for experts or consultants or labourers, laptops, tablets, drones and laboratory animals is not supported**.
- Awarded PIs may also support MSc student as part of the project, request funding for international conference grant, industrial link grant, mobility grant and open access publication grant. **Full details of each component are laid out in the guidelines.**
- The programme has an additional component which seeks to enhance the productivity of female scientists returning to academia after a maternity leave, *scientist-after-child* grant. Full details of this component can be found in the guidelines.

### Eligibility

- Applying *Principal Investigators* must be nationals of an eligible country, who holds a PhD and has good research experience. The grant should operate within a university or a research institution in one of the African countries lagging in science and technology.
- The PI must be 40 years old or younger. Any applicant turning 41 in the year of application is not eligible.
- The PI must have obtained their Ph.D. within the last 5 years in a country other than their home country.
- The PI must have returned to their home country (refer to list in the guidelines) within the last 36 months or must have returned home before the end of 2024.
- The PI must hold, be offered or be in the process of accepting a position at an academic and/or research institution (including international research centers) in their home country.
- The PI must be national of an eligible African country that is lagging in science and technology (refer to list in the guidelines).

- Applicant must at the time of application NOT have an active research grant with TWAS or OWSD Early Career Women Scientists (ECWS) Fellowship.
- Applications from women scientists and those working in Least Developed Countries are especially encouraged.

- Please be advised that applicants may apply for only one programme per calendar year in the TWAS and OWSD portfolio. Applicants will not be eligible to visit another institution in that year under the TWAS [Visiting Scientists](#) the [Visiting Professor](#) programmes. One exception: The head of an institution who *invites* an external scholar to share his/her expertise under the TWAS [Visiting Professor](#) programme or the TWAS [Visiting Expert](#) programme may still apply for another programme.

## Agreement

- If selected, a trilateral written agreement is drawn up between TWAS, the Principal Investigator and the home institution. The institution undertakes to administer the grant according to the agreement and to provide laboratory space, salaries and other facilities necessary for the project. Equipment, consumables and literature provided for the project through the SG-NAPI grant programme remain the property of the home institution after the project is completed.
- In general, the grant funds are kept at TWAS for the purchase of items requested by the grant holder. TWAS places the orders with the supplier(s) upon receipt of proforma invoices submitted by the grant holder in accordance with the approved itemized budget.
- The agreement will also provide details on how to activate other benefits of the grant such as support for MSc students, international conference grant, industrial link grant, mobility grant, open access publication grant and *scientist-after-child* grant.
- Grant holders must submit a final report within one year from the date of the last purchase.

We strongly encourage applicants to judge the legitimacy and credentials of conferences to help decide whether or not to attend. The [Think.Check.Attend](#) initiative might be useful in this regard.
- The date of travel must occur within six months of funding being awarded.
- Unsuccessful applicants may not submit a new application within 12 months of their initial application unless otherwise advised to by the Grants Administrator.
- Applicants should not have received other funding from The Company of Biologists in the past 12 months.
- Funding of multiple applications from the same lab or department will be limited, and it is likely that only one will be awarded each round.

### Guidelines for completing the application:

- The application and all supporting documents must be completed in English.
- It is your responsibility to ensure that you meet the criteria required for a grant.
- Expenses include registration fees, travel, subsistence, accommodation and visa fees. Travel insurance costs are not to be included in the expenses.

- A copy of any abstract submitted to the meeting or conference for which funding is requested.
- Curriculum Vitae.

### Terms and conditions for successful applicants:

- Support from DMM and The Company of Biologists should be acknowledged in any presentations given or posters displayed at the meeting or course (logo will be supplied).
- Any unspent funds must be returned within one month of the end of the travel.
- If for any reason you do not attend the conference, workshop or course, please email [dmmtravelgrants@biologists.com](mailto:dmmtravelgrants@biologists.com). Please also arrange for the funds to be returned, in full.
- Successful applicants will be required to keep all of the receipts related to the visit to upload on the via the online application portal on your return.

## AfricaLics Travel Grant

Students from low and low-middle income countries as per [DAC OECD list of countries](#) can apply for travel support when accepted as participants for AfricaLics PhD Academies and Research Conferences; when funds allow.

To apply for funding, the following conditions must be met:

- Your paper must have been accepted and have been informed of a confirmed place in the event.
- Available travel support funding is prioritised for PhD students and early career researchers/ post-doctoral students based at African Universities.
- You must be a national of a low income or low-middle income country. Currently, AfricaLics is unable to provide travel support to anyone who is a national of, or studying in, a country designated as high income.
- If your paper is with a co-author(s), we can only give travel support to one presenting author.
- We do not grant travel support to applicants residing in the country where the conference is located.
- We do not support employees from Ministries and other government agencies (e.g. development banks).

If you are eligible for travel support, you must complete a travel support request form PRIOR to your travel and before the deadline provided for the event. [The travel support request form is available here](#).

Please note that travel support is provided as follows:

- **Travel support covers return airfares only. These must be the cheapest fare and economy class tickets.** We are unable to reimburse visa costs, ground transportation, transit hotel bills or other related travel costs.
- The reimbursement procedure starts **AFTER** the conference. It is therefore NOT possible to receive cheque, cash or other forms of payment at the conference.
- We cannot refund costs larger than the amount you are granted.
- We cannot refund costs larger than the documented costs, which mean that we need original tickets and receipts **AFTER** the conference. You must scan and post back to us after the event your original tickets/receipt and boarding passes/stubs. If you do not return these, your travel support claim cannot be processed.
- The AfricaLics Secretariat can only provide travel support in terms of reimbursement of travel costs AFTER the conference: **The AfricaLics Secretariat is unable to support prepaid tickets.**

History shows that the number of applicants is proportionally larger than our resources for travel support so please try to look for other sources of finance that can fully or partly finance your travel. We receive many applications and since our funds for travel support are limited, applicants **should not expect to receive 100% of their funding request.**
